## What this policy is for

#### **Policy statement**

EBC is committed to protecting personal data and respecting the rights of our **data subjects;** the people whose **personal data** we collect and use. We value the personal information entrusted to us and we respect that trust, by complying with all relevant laws, and adopting good practice.

We process personal data to help us:

- 1. maintain our list of church members and regular attenders
- provide pastoral support for members and others connected with our church
- 3. provide services to the community
- 4. safeguard children, young people and adults at risk
- 5. recruit, support and manage staff and volunteers
- 6. maintain our accounts and records
- 7. promote our services
- 8. respond effectively to enquirers and handle any complaints

This policy has been approved by the church's leadership, who are also the Charity Trustees and are responsible for ensuring that we comply with all our legal obligations. It sets out the legal rules that apply whenever we obtain, store or use personal data.

#### Why this policy is important

We are committed to protecting personal data from being misused, getting into the wrong hands as a result of poor security or being shared carelessly, or being inaccurate, as we are aware that people can be upset or harmed if any of these things happen.

This policy sets out the measures we are committed to taking as an organisation and, what each of us will do to ensure we comply with the relevant legislation.

In particular, we will make sure that all personal data is:

- 1. processed lawfully, fairly and in a transparent manner
- 1. processed for **specified**, **explicit and legitimate purposes** and not in a manner that is incompatible with those purposes
- 2. adequate, relevant and limited to what is necessary for the purposes for which it is being processed
- 3. accurate and, where necessary, up to date
- 4. **not kept longer than necessary** for the purposes for which it is being processed
- 5. processed in a **secure** manner, by using appropriate technical and organisational means
- 6. processed in keeping with the **rights of data subjects** regarding their personal data

#### How this policy applies to you & what you need to know

As an employee, trustee or volunteer processing personal information on behalf of the church, you are required to comply with this policy. If you think that you have accidentally breached the policy it is important that you contact our Data Protection Officer immediately so that we can take swift action to try and limit the impact of the breach.

Anyone who breaches the Data Protection Policy may be subject to disciplinary action, and where that individual has breached the policy intentionally, recklessly, or for personal benefit they may also be liable to prosecution or to regulatory action.

As a leader/manager: You are required to make sure that any procedures that involve personal data, that you are responsible for in your area, follow the rules set out in this Data Protection Policy.

**As a data subject of** EBC: We will handle your personal information in line with this policy.

As an appointed data processor/contractor: Companies who are appointed by us as a data processor are required to comply with this policy under the contract with us. Any breach of the policy will be taken seriously and could lead to us taking contract enforcement action against the company, or terminating the contract. Data processors have direct obligations under the GDPR, primarily to only process data on instructions from the controller (us) and to implement appropriate technical and organisational measures to ensure a level of security appropriate to the risk involved.

**Our Data Protection Officer** is responsible for advising EBC and its staff and members about their legal obligations under data protection law, monitoring compliance with data protection law, dealing with data security breaches and with the development of this policy. Any questions about this policy or any concerns that the policy has not been followed should be referred to them.

Before you collect or handle any personal data as part of your work (paid or otherwise) for EBC, it is important that you take the time to read this policy carefully and understand what is required of you, as well as the organisation's responsibilities when we process data.

Our procedures will be in line with the requirements of this policy, but if you are unsure about whether anything you plan to do, or are currently doing, might breach this policy you must first speak to the Data Protection Officer

#### Training and guidance

We will provide general training at least annually for all staff to raise awareness of their obligations and our responsibilities, as well as to outline the law.

We may also issue procedures, guidance or instructions from time to time.

Managers/leaders must set aside time for their team to look together at the implications for their work.

## Our data protection responsibilities

#### What personal information do we process?

In the course of our work, we may collect and process information (personal data) about many different people (data subjects). This includes data we receive straight from the person it is about, for example, where they complete forms or contact us. We may also receive information about data subjects from other sources including, for example, previous employers [and other examples].

We process personal data in both electronic and paper form and all this data is protected under data protection law. The personal data we process can include

information such as names and contact details, education or employment details, and visual images of people.

In some cases, we hold types of information that are called **"special categories"** of data in the GDPR. This personal data can <u>only</u> be processed under strict conditions.

**'Special categories'** of data (as referred to in the GDPR) includes information about a person's: racial or ethnic origin; political opinions; religious or similar (e.g. philosophical) beliefs; trade union membership; health (including physical and mental health, and the provision of health care services); genetic data; biometric data; sexual life and sexual orientation.

We may process information relating to criminal proceedings or offences or allegations of offences to safeguard against any risks posed to others under Article 6(1)(f) UK GDPR where the processing is necessary for the purposes of the legitimate interests of EBC but not where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data, in particular where the data subject is a child.

We may also process special category or criminal convictions etc data ("criminal offence data") where it fulfils one of the substantial public interest conditions under Schedule 1, Part 2 of the Data Protection Act 2018, in particular, Conditions 10, 11, 12, 18 and 19.

We may also seek to obtain, use and retain criminal offence data in reliance upon Condition 31 relating to criminal convictions under Schedule 1, Part 3 of the Data Protection Act 2018.

For the purposes of Schedule 1, Part 4 of the Data Protection Act 2018, more information about EBC processing of special category and criminal convictions data under Conditions 10, 11, 12, 18, 19 and 31 can be found in the "Appropriate Policy Document" in the section titled "APPROPRIATE POLICY DOCUMENT EBC" of this policy.

The processing of special category and criminal convictions data described above will only ever be carried out on the advice of statutory authorities, the Ministries Team of the Baptist Union of Great Britain or our Regional Association Safeguarding contact person. Other data may also be considered 'sensitive' such as bank details, but will not be subject to the same legal protection as the types of data listed above.

#### Making sure processing is fair and lawful

Processing of personal data will only be fair and lawful when the purpose for the processing meets a legal basis, as listed below, and when the processing is transparent. This means we will provide people with an explanation of how and why we process their personal data at the point we collect data from them, as well as when we collect data about them from other sources.

#### How can we legally use personal data?

Processing of personal data is only lawful if at least one of these legal conditions, as listed in Article 6 of the GDPR, is met:

- 1. the processing is **necessary for a contract** with the data subject
- 2. the processing is necessary for us to comply with a legal obligation
- the processing is necessary to protect someone's life (this is called "vital interests")
- 4. the processing is necessary for us to perform a task in the **public interest**, and the task has a clear basis in law
- 5. the processing is necessary for legitimate interests pursued by EBC or another organisation, <u>unless</u> these are overridden by the interests, rights and freedoms of the data subject
- 6. If none of the other legal conditions apply, the processing will only be lawful if the data subject has given their clear **consent**

#### How can we legally use 'special categories' of data?

Processing of 'special categories' of personal data is only lawful when, in addition to the conditions above, one of the extra conditions, as listed in Article 9 of the GDPR, is met. These conditions include where:

- 1. the processing is necessary for carrying out our obligations under employment and social security and social protection law
- 2. the processing is necessary for safeguarding the vital interests (in emergency, life or death situations) of an individual and the data subject is incapable of giving consent
- 3. the processing is carried out in the course of our legitimate activities and only relates to our members or persons we are in regular contact with in connection with our purposes

- 4. the processing is necessary for pursuing legal claims
- 5. If none of the other legal conditions apply, the processing will only be lawful if the data subject has given their explicit consent

Before deciding which condition should be relied upon, we may refer to the original text of the GDPR as well as any relevant guidance, and seek legal advice as required.

#### What must we tell individuals before we use their data?

If personal data is collected directly from the individual, we will inform them about; our identity/contact details, explaining our legitimate interests, and explaining, where relevant, the consequences of not providing data needed for a contract or statutory requirement; who we will share the data with; if we plan to send the data outside of the European Union; how long the data will be stored and the data subjects' rights.

- 1) This information is commonly referred to as a 'Privacy Notice'.
- 2) This information will be given at the time when the personal data is collected.

If data is collected from another source, rather than directly from the data subject, we will provide the data subject with the information described in section 0 as well as: the categories of the data concerned; and the source of the data.

This information will be provided to the individual in writing and no later than within **1 month** after we receive the data, unless a legal exemption under the GDPR applies. If we use the data to communicate with the data subject, we will at the latest give them this information at the time of the first communication.

If we plan to pass the data onto someone else outside of EBC, we will give the data subject this information <u>before</u> we pass on the data.

#### When we need consent to process data

Where none of the other legal conditions apply to the processing, and we are required to get consent from the data subject, we will clearly set out what we are asking consent for, including why we are collecting the data and how we plan to use it. Consent will be specific to each process we are requesting consent for and we will only ask for consent when the data subject has a real choice whether or not to provide us with their data. Consent can however be withdrawn at any time and if withdrawn, the processing will stop. Data subjects will be informed of their right to withdraw consent and it will be as easy to withdraw consent as it is to give consent.

#### **Processing for specified purposes**

We will only process personal data for the specific purposes explained in our privacy notices (as described above in What must we tell individuals before we use their data?.) or for other purposes specifically permitted by law. We will explain those other purposes to data subjects in the way described in the section titled\_Making sure processing is fair and lawful, unless there are lawful reasons for not doing so.

#### Data will be adequate, relevant and not excessive

We will only collect and use personal data that is needed for the specific purposes described above (which will normally be explained to the data subjects in privacy notices). We will not collect more than is needed to achieve those purposes. We will not collect any personal data "just in case" we want to process it later.

#### Accurate data

We will make sure that personal data held is accurate and, where appropriate, kept up to date. The accuracy of personal data will be checked at the point of collection and at appropriate points later on.

#### Keeping data and destroying it

We will not keep personal data longer than is necessary for the purposes that it was collected for. We will comply with official guidance issued to our sector about retention periods for specific records.

Information about how long we will keep records for can be found in our Data Retention Schedule, EBC-10.

#### Security of personal data

We will use appropriate measures to keep personal data secure at all points of the processing. Keeping data secure includes protecting it from unauthorised or unlawful processing, or from accidental loss, destruction or damage.

We will implement security measures which provide a level of security which is appropriate to the risks involved in the processing.

Measures will include technical and organisational security measures. In assessing what measures are the most appropriate we will take into account the following, and anything else that is relevant:

- 1. the quality of the security measure
- 2. the costs of implementation
- 3. the nature, scope, context and purpose of processing
- 4. the risk (of varying likelihood and severity) to the rights and freedoms of data subjects
- 5. the risk which could result from a data breach

Measures may include:

- 1. technical systems security
- 2. measures to restrict or minimise access to data
- measures to ensure our systems and data remain available, or can be easily restored in the case of an incident
- 4. physical security of information and of our premises
- 5. organisational measures, including policies, procedures, training and audits
- 6. regular testing and evaluating of the effectiveness of security measures

#### Keeping records of our data processing

To show how we comply with the law we will keep clear records of our processing activities and of the decisions we make concerning personal data (setting out our reasons for those decisions).

# Working with people we process data about (data subjects)

#### Data subjects' rights

We will process personal data in line with data subjects' rights, including their right to:

1. request access to any of their personal data held by us (known as a Subject Access Request)

- 2. ask to have inaccurate personal data changed
- **3.** restrict processing, in certain circumstances
- 4. object to processing, in certain circumstances, including preventing the use of their data for direct marketing
- 5. data portability, which means to receive their data, or some of their data, in a format that can be easily used by another person (including the data subject themselves) or organisation
- 6. not be subject to automated decisions, in certain circumstances and
- 7. withdraw consent when we are relying on consent to process their data

If a colleague receives any request from a data subject that relates or could relate to their data protection rights, this will be forwarded to our Data Protection Officer **immediately**.

We will act on all valid requests as soon as possible, and at the latest within **one calendar month,** unless we have reason to, and can lawfully extend the timescale. This can be extended by up to two months in some circumstances.

All data subjects' rights are provided free of charge.

Any information provided to data subjects will be concise and transparent, using clear and plain language.

#### **Direct marketing**

We will comply with the rules set out in the GDPR, the Privacy and Electronic Communications Regulations (PECR) and any laws which may amend or replace the regulations around **direct marketing**. This includes, but is not limited to, when we make contact with data subjects by post, email, text message, social media messaging, telephone (both live and recorded calls) and fax.

**Direct marketing** means the communication (by any means) of any advertising or marketing material which is directed, or addressed, to individuals. "Marketing" does not need to be selling anything, or be advertising a commercial product. It includes contact made by organisations to individuals for the purposes of promoting the organisation's aims.

Any direct marketing material that we send will identify EBC as the sender and will describe how people can object to receiving similar communications in the future. If

a data subject exercises their right to object to direct marketing we will stop the direct marketing as soon as possible.

# Working with other organisations & transferring data

#### Sharing information with other organisations

We will only share personal data with other organisations or people when we have a legal basis to do so and if we have informed the data subject about the possibility of the data being shared (in a privacy notice), unless legal exemptions apply to informing data subjects about the sharing. Only authorised and properly instructed staff are allowed to share personal data.

We will keep records of information shared with a third party, which will include recording any exemptions which have been applied, and why they have been applied. We will follow the ICO's statutory <u>Data Sharing Code of Practice</u> (or any replacement code of practice) when sharing personal data with other data controllers. Legal advice will be sought as required.

#### Data processors

Before appointing a contractor who will process personal data on our behalf (a data processor) we will carry out due diligence checks. The checks are to make sure the processor will use appropriate technical and organisational measures to ensure the processing will comply with data protection law, including keeping the data secure, and upholding the rights of data subjects. We will only appoint data processors who can provide us with sufficient guarantees that they will do this.

We will only appoint data processors on the basis of a written contract that will require the processor to comply with all relevant legal requirements. We will continue to monitor the data processing, and compliance with the contract, throughout the duration of the contract.

#### Transferring personal data outside the United Kingdom (UK)

Personal data cannot be transferred (or stored) outside of the United Kingdom unless this is permitted by the GDPR. This includes storage on a "cloud" based service where the servers are located outside the UK.

We will only transfer data outside the UK where it is permitted by one of the conditions for non-UK transfers in the GDPR

## Managing change & risks

#### **Data protection impact assessments**

When we are planning to carry out any data processing which is likely to result in a high risk we will carry out a Data Protection Impact Assessment (DPIA). These include situations when we process data relating to vulnerable people, trawling of data from public profiles, using new technology, and transferring data outside the EU. Any decision not to conduct a DPIA will be recorded.

We may also conduct a DPIA in other cases when we consider it appropriate to do so. If we are unable to mitigate the identified risks such that a high risk remains we will consult with the ICO.

DPIAs will be conducted in accordance with the ICO's Code of Practice '<u>Conducting</u> <u>privacy impact assessments</u>'.

#### **Dealing with data protection breaches**

Where staff or volunteers, or contractors working for us, think that this policy has not been followed, or data might have been breached or lost, this will be reported **immediately** to the Data Protection Officer.

We will keep records of personal data breaches, even if we do not report them to the ICO.

We will report all data breaches which are likely to result in a risk to any person, to the ICO. Reports will be made to the ICO within **72 hours** from when someone in the church becomes aware of the breach.

In situations where a personal data breach causes a high risk to any person, we will (as well as reporting the breach to the ICO), inform data subjects whose information is affected, without undue delay.

This can include situations where, for example, bank account details are lost or an email containing sensitive information is sent to the wrong recipient. Informing data subjects can enable them to take steps to protect themselves and/or to exercise their rights.

## Definitions and useful terms

The following terms are used throughout this policy and have their legal meaning as set out within the GDPR. The GDPR definitions are further explained below:

-	
Data controller	means any person, company, authority or other body who (or which) determines the means for processing personal data and the purposes for which it is processed. It does not matter if the decisions are made alone or jointly with others.
	The data controller is responsible for the personal data which is processed and the way in which it is processed. We are the data controller of data which we process.
Data processors	include any individuals or organisations, which process personal data on our behalf and on our instructions e.g. an external organisation which provides secure waste disposal for us. This definition will include the data processors' own staff (note that staff of data processors may also be data subjects).
Data subjects	include <u>all</u> living individuals who we hold or otherwise process personal data about. A data subject does not need to be a UK national or resident. All data subjects have legal rights in relation to their personal information. Data subjects that we are likely to hold personal data about include:
	1) the people we care for and support
	2) our employees (and former employees)
	<ol> <li>consultants/individuals who are our contractors or employees working for them</li> </ol>
	4) volunteers
	5) tenants
	6) trustees
	7) complainants
	8) supporters
	9) enquirers
	10) friends and family

	11) advisers and representatives of other organisations	
ICO	means the Information Commissioners Office which is the UK's regulatory body responsible for ensuring that we comply with our legal data protection duties. The ICO produces guidance on how to implement data protection law and can take regulatory action where a breach occurs.	
Personal data	means any information relating to a natural person (living person) who is either identified or is identifiable. A natural person must be an individual and cannot be a company or a public body. Representatives of companies or public bodies would, however, be natural persons.	
	Personal data is limited to information about <u>living individuals</u> and does not cover deceased people.	
	Personal data can be factual (for example, a name, address or date of birth) or it can be an opinion about that person, their actions and behaviour	
Privacy notice	means the information given to data subjects which explains how we process their data and for what purposes.	
Processing	is very widely defined and includes any activity that involves the data. It includes obtaining, recording or holding the data, or carrying out any operation or set of operations on the data including organising, amending, retrieving, using, disclosing, erasing or destroying it. Processing can also include transferring personal data to third parties, <u>listening</u> to a recorded message (e.g. on voicemail) or <u>viewing</u> personal data on a screen or in a paper document which forms part of a structured filing system. Viewing of clear, moving or stills images of living individuals is also a processing activity.

## Appropriate Policy Document EBC

Schedule 1, Part 4, Data Protection Act 2018: processing of special category and criminal offence data for the purposes of Parts 1, 2 or 3 of Schedule 1 of the Data Protection Act 2018.

#### Who we are

EBC is a Baptist church in Swanage

#### What this policy does

This policy explains how and why EBC collects, processes and shares special category personal data about you and data relating to criminal convictions etc in order to carry out our functions, in accordance with the data protection principles set out in the UK General Data Protection Regulation (UK GDPR.) Pursuant to Part 4 of Schedule 1 of the Data Protection Act 2018 (DPA 2018), special category data (Parts 1 and 2 of Schedule 1), and data relating to criminal convictions etc (Part 3 of Schedule 1), can only be processed lawfully if it is carried out in accordance with this policy. EBC staff, trustees and volunteers must therefore have regard to this policy when carrying out sensitive processing on our behalf.

#### Our approach to data protection

- EBC is committed to ensuring that the collection and processing of personal data is carried out in accordance with the UK GDPR and the DPA 2018.
- This is implemented through the provision of training for all staff, trustees and volunteers on data protection to ensure compliance with our policies and procedures.
- EBC values openness and transparency, and we have committed to and published a number of policies and processes to assist data subjects and to explain how we handle personal data. These include the EBC data protection policy, our data retention schedule and the privacy notices on our website https://www.emmanuelbc.org.uk/ which describe what information we hold, why we hold it, the legal basis for holding it, who we share it with, and the period we will hold it for.

- EBC has appointed a Data Protection Officer (DPO)/Trustee, who is Ian Snell. The DPO/Data Protection Trustee has the day to day responsibility for ensuring that the information EBC collects is necessary for the purposes required and is not kept in a manner that can identify the individual any longer than necessary. Data protection training is provided for all new staff and volunteers and an annual update on data protection is provided to staff, trustees and volunteers, to ensure that everyone is familiar with EBC's data protection policies and procedures and in particular the processing of any special category and criminal offence data. The DPO/Data Protection Trustee will review any Data Protection Impact Assessments for EBC.
- Due to the nature of the activities performed by EBC, the church may need to share information with other organisations e.g. the Baptist Union of Great Britain and Southern Counties Baptist Association (SCBA) and third parties, including statutory bodies and professional advisers, details of which can be found in our privacy notice at https://www.emmanuelbc.org.uk/.

In summary, Article 5 of the UK GDPR states that personal data shall be:

- processed lawfully, fairly and transparently
- collected for specific and legitimate purposes and processed in accordance with those purposes
- adequate, relevant and limited to what is necessary for the stated purposes
- accurate and, where necessary, kept up-to-date
- retained for no longer than necessary, and
- kept secure

#### Special category data and criminal convictions etc data

#### Special category data

Personal data refers to any information by which a living individual can be identified. Individual identification can be by information alone or in conjunction with other information. Certain categories of personal data have additional legal protections when being processed. These categories are referred to in the legislation as "special category data" and are data concerning:

- health
- racial or ethnic origin
- political opinions

- religious or philosophical beliefs
- trade union membership
- genetic data
- biometric data
- sex life or sexual orientation

#### **Criminal convictions etc data**

The processing of criminal convictions etc data also has additional legal safeguards. Criminal convictions etc data ("criminal offence data") includes information about criminal allegations, criminal offences, criminal proceedings and criminal convictions.

## Special category and criminal offence data we process about you

EBC collects, processes and shares special category and criminal convictions data where it is necessary in order to carry out our functions. This processing is usually carried by the Designated Person for Safeguarding, the minister or certain charity trustees for the purpose of safeguarding against any risks posed to others in our church or attending our church activities by those who are involved in our church, to mitigate the risk of individuals committing criminal offences (including of a sexual nature) and to assess individuals' suitability for ministry or other work at EBC, including by reference to risks they may pose to others. These functions and the requisite processing of personal data are matters of substantial public interest.

If we process personal information about you, you are a "data subject." Below is a non-exhaustive list of categories of data subjects who we might process information about:

- Employees, volunteers, workers or charity trustees of EBC;
- A child or individual in membership with or associated with EBC;

EBC will share this data with third parties only where strictly necessary (please see the section "Who we share your personal data with" below).

Special category data and criminal offence data may be collected from the following non-exhaustive list of sources:

• Data subjects

- Church members or individuals in regular contact with the church including the minister, church officers, workers or volunteers, and the church's Designated Person for Safeguarding
- The Baptist Union of Great Britain (BUGB) Specialist Teams, in particular the BUGB Ministries Team and National Safeguarding Team.
- Our Regional Association Southern Counties Baptist Association (SCBA) and, in particular, our SCBA Safeguarding contact person.
- Police, Social Services or the Local Authority Designated Officer for safeguarding.

EBC may also obtain and process this data for other statutory and legal obligations for example, including, but not limited to:

- > responding to data subject access requests under data protection legislation
- ➢ in connection with our duties under the Equality Act 2010.

## The legal basis for processing your special category or criminal convictions data

Privacy Notices are available on the EBC website at [insert church website here]. The Privacy Notices set out the legal bases for our processing of your personal data.

Where we process special category and criminal offence data it will be by reference to Article 6(1)(f) UK GDPR and Conditions 10, 11, 12, 18, 19 and 31 of Schedule 1 Data Protection Act 2018, which are described below:

Article 6(1)(f) UK GDPR, where the processing is necessary for the purposes of the legitimate interests of EBC, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data, in particular where the data subject is a child.

Special category or criminal offence data may also be processed by EBC where it fulfils one of the substantial public interest conditions under Schedule 1, Part 2 of the Data Protection Act 2018:

a) Condition 10:

where the processing is necessary for the purposes of the prevention or detection of an unlawful act, it must be carried out without the consent of the data subject so as not to prejudice those purposes, and is necessary for reasons of substantial public interest. In order to mitigate the risk of individuals committing criminal offences, including of a sexual nature, EBC may undertake a risk assessment, receive, make a record of and share information about an individual who has been reported to us by another individual or a statutory authority, where there is a significant concern about their conduct and the risk they may pose to others.

b) Condition 11:

where the processing is necessary for the exercise of a protective function, it must be carried out without the consent of the data subject so as not to prejudice the exercise of that function, and is necessary for reasons of substantial public interest. In this paragraph, "protective function" means a function which is intended to protect members of the public against – dishonesty, malpractice or other seriously improper conduct, unfitness or incompetence, mismanagement in the administration of a body or association, or failures in services provided by a body or association.

EBC may exercise protective functions in partnership with BUGB's Safeguarding and Ministries Teams or the Regional Association, which include assessing individuals' suitability for ministry or other work within EBC, including by reference to risks they may pose to others. These functions are discharged by custom, practice and with the consensus of the members of EBC and the requisite processing of personal data is a matter of substantial public interest.

c) Condition 12:

where the processing is necessary for the purposes of complying with, or assisting other persons to comply with, a regulatory requirement which involves a person taking steps to establish whether another person has committed an unlawful act, or been involved in dishonesty, malpractice or other seriously improper conduct, and in the circumstances the controller cannot reasonably be expected to obtain the consent of the data subject to the processing, and the processing is necessary for reasons of substantial public interest. EBC may, in partnership with the Regional Association or BUGB, investigate and risk assess an individual's suitability for ministry or other work within or connected with EBC or the Baptist family, which is in the substantial public interest and forms an integral part of "generally accepted principles of good practice" as per the definition of "regulatory requirement" in Condition 12.

d) Condition 18:

where the processing is necessary for the purposes of protecting an individual from neglect or physical, mental or emotional harm, or protecting the physical, mental or emotional well-being of an individual, the individual is - aged under 18, or aged 18 and over and at risk, the processing is carried out without the consent of the data subject for one of the reasons listed in sub-paragraph (2), and (d) the processing is necessary for reasons of substantial public interest. (2) The reasons mentioned in sub-paragraph (1)(c) are – (a) in the circumstances, consent to the processing cannot be given by the data subject; (b) in the circumstances, the controller cannot reasonably be expected to obtain the consent of the data subject to the processing; (c) the processing must be carried out without the consent of the data subject because obtaining the consent of the data subject would prejudice the provision of the protection mentioned in sub-paragraph (1)(a).

EBC may process criminal and special category data for the purposes of safeguarding minors and vulnerable persons or adults at risk.

e) Condition 19:

where the processing is necessary for the purposes of protecting the economic well-being of an individual at economic risk who is aged 18 and over and the processing is of data concerning health, is carried out without the consent of the data subject for one of the reasons listed in sub-paragraph (2), and is necessary for reasons of substantial public interest. An "individual at economic risk" means an individual who is less able to protect his or her economic well-being by reason of physical or mental injury, illness or disability. EBC may seek to rely on this condition if it is required to investigate allegations of financial Page 26 of 29 abuse by an individual in ministry or other work or who is involved in the life of EBC, for the purpose of safeguarding vulnerable persons or adults at risk.

EBC may also seek to obtain, use and retain criminal offence data in reliance upon the following additional condition relating to criminal convictions under Schedule 1, Part 3 of the Data Protection Act 2018:

f) Condition 31:

where the processing is carried out by a not-for-profit body with a religious aim in the course of its legitimate activities with appropriate safeguards where it relates solely to the members or former members of the body or to persons in regular contact with it in connection with its purposes, and the personal data is not disclosed outside that body without the consent of the data subjects.

#### Who we share your personal data with

We are required to share your data with third parties where we have a legal obligation to do so. We may also share information with our partner organisations with whom we have a Data Sharing Agreement, or as set out in our Privacy Notices available here: <u>https://www.emmanuelbc.org.uk/</u>

The persons/organisations we may share your special category and criminal offence data with are:

- Our charity trustees, employees, contractors and volunteers on a need-toknow basis;
- The BUGB Specialist Teams;
- Southern Counties Baptist Association;
- Churches and other appointing or employing bodies as appropriate
- Counsellors, professional supervisors and risk assessment consultants
- The Police and Social Services, Local Authority Designated Officers and other statutory agencies
- The Disclosure and Barring Service and our DBS Checking Company

Before sharing information with any of the above persons or organisations, careful consideration is given to the rights and freedoms of the data subject against what is needed to be shared to achieve our overarching goal of

safeguarding children, young people and adults at risk from harm within EBC and to support and promote exemplary ministry. Special category and criminal offence data is only disclosed where it is reasonably necessary to do so and a record and full details of any disclosure to third parties is kept in the church safe.

#### Automated decision making

Currently EBC undertakes no automated decision making in relation to your personal data.

#### How we keep your data secure and how long we keep it for

EBC deploys a range of technical and organisational measures to protect the personal data it holds and processes. Controls include but are not limited to

• Acceptable use of IT equipment and systems defined in the Safeguarding Policy

These measures are under constant review by EBC.

EBC has a Data Retention Schedule which lists the data we hold and how long we hold it for. To find out how long we keep your data for please see our Data Retention Schedule.

#### Your rights in relation to the data we hold

Data protection legislation provides you with a number of rights relating to your personal data, including your special category and criminal conviction etc data. These rights are subject to some specific exemptions. Your rights may include:

- the right to access your data
- the right to have your data corrected if it is wrong or incomplete
- the right to request restrictions to the processing of your data
- the right to object to your data being processed
- the right to have your data erased
- the right to be informed about how your data is processed
- rights relating to automated decision making and data portability

You should keep us informed of any changes to your information so that we can be confident that the data we hold about you is accurate.
